AN ACT TO PROVIDE TEMPORARILY FOR THE CONTINUATION OF REGIONAL, DISTRICT AND AREA REVOLUTIONARY COMMITTEES FOR A FURTHER PERIOD OF ONE YEAR INCLUSIVE FROM THE FIRST DAY OF JANUARY NINETEEN HUNDRED AND NINETY FIVE AND TO PROVIDE FOR OTHER MATTERS CONNECTED THEREWITH OR INCIDENTAL THERETO.

1. (1) This Act may be cited as the Revolutionary Committees Decree (Temporary Provisions) Act, 1984 and shall be read as one with the Revolutionary Committees Decree (Decree No. 1) of 1979 and the Administrative Authority Act, (Act No. 3) of 1981.

(2) This Act shall come into operation on the first day of January, 1985.

2. The members of the Regional, District and Area Revolutionary Committees who, immediately before the thirty first day of December 1984, are respectively members of the Regional, District and Area Revolutionary Committees under the Revolutionary Committees Decree, Number 1 of 1979 as amended by the Administrative Authority Act, Number 3 of 1981 and who shall cease to be members thereafter, shall continue to be, respectively, the members of the Regional, District and Area Revolutionary Committees under the Constitution immediately after the thirty first day of December, 1984.

**Duration.** 3. This Act shall continue in operation for a period of one year and no longer unless its operation is terminated earlier by the President and Chairman of the Revolutionary Council by notice published in the Gazette.

**Savings.** 4. The expiration of this Act shall not affect the validity of anything done in pursuance thereof.
