AN ACT TO DEFINE A ZANZIBARI AND TO PROVIDE
FOR OTHER MATTERS CONNECTED THEREWITH AND
INCIDENTAL THERETO.

ENACTED BY THE HOUSE OF REPRESENTATIVES, ZANZIBAR.

Short title 1. This Act may be cited as the Zanzibari
and
commencement. Act, and shall be deemed to have come into operation
on the 12th day of January, 1985.

Interpretation. 2. In this Act, unless the context otherwise
requires :-

"full age" means the age of majority as defined
in the Majority Decree, Cap.53;

"citizen" means a citizen of the United Republic
of Tanzania as defined in the Citizenship
Act of the United Republic;

"the Minister" means the Chief Minister;

"Zanzibar" means Zanzibar as defined in the
Zanzibar Constitution.

A Zanzibari. 3.(1) Any person who is a citizen of Tanzania
in accordance with the laws relating to Citizenship,
and that he has been residing in Zanzibar before and
upto 12th January, 1964 shall be a Zanzibari.

(2) Any person who, as from the 26th day of April, 1964 is a Citizen of Tanzania and that he was born in Zanzibar shall be a Zanzibari if both of his parents or his father or his mother is a Zanzibari in accordance with this Act.

(3) Any person who is a citizen, and that before the 26th day of April, 1964 was a Zanzibari shall be a Zanzibari if he has not lost his Tanzanian citizenship.

(4) Any person who is a citizen of Tanzania and that both of his parents or his father or his mother is a Zanzibari in accordance with subsections (1), (2) and (3) above shall be a Zanzibari.

4. Any person who is a citizen of Tanzania in accordance with the laws relating to citizenship and -

- (a) he has been residing in Zanzibar for a consecutive period of fifteen years; and
- (b) he has sufficient knowledge to write and read Kiswahili; and
- (c) that he is of a good character; and
- (d) that he has lawfully entered Zanzibar and has obeyed all prevailing laws and regulations of Zanzibar; and
- (e) that he is of full age; and
- (f) that he intends to continue residing in Zanzibar,

may be eligible to be a Zanzibari.

Deprivation

5. A Zanzibari who is such by naturalisation shall cease to be a Zanzibari if -

- (a) he is deprived of his Tanzanian citizenship; or

- (b) he is deprived of his status as such by an order of the Minister and in accordance with the laid down procedures.


6. Subject to section 3 of this Act, the Minister may make regulations for -

- (a) the renunciation by any person of his status as a Zanzibari;
- (b) the deprivation of any person of his status as a Zanzibari; and
- (c) any other thing which the Minister thinks fit to do and which is for the better carrying out of the provisions of this Act.

7. The Regulation of Citizens and Residents Decree, No.11 of 1966 is hereby repealed.



3.(1) Mtu ye yote ambae ni raia wa Tanzania
kwa mujibu wa Sheria za Uraia za Tanzania na kwamba
amekuwa akiishi Zanzibar kabla na hadi kufikia
tarehe 12 Januari, 1964 atakuwa Mzanzibari kwa
mujibu wa Sheria hii.

(2) Mtu ye yote ambae, kuanzia tarehe 26 April 1964 ni raia wa Tanzania na kwamba amezaliwa Zanzibar atakuwa Mzanzibari ikiwa wazazi wake wote wawili au baba yake au mama yake ni Mzanzibari kwa mujibu wa Sheria hii.

(3) Mtu ye yote ambae ni raia wa Tanzania, na ambae kabla ya tarehe 26 April, 1964 alikuwa Mzanzibari ataendelea kuwa Mzanzibari ikiwa hakupoteza uraia wake wa Tanzania.

(4) Mtu ye yote ambae ni raia wa Tanzania na kwamba wazazi wake wote wawili au baba yake au mama yake ni Mzanzibari kwa mujibu wa vijifungu (1), (2) na (3) vya kifungu hichi atakuwa Mzanzibari.

4. Mtu ye yote ambae ni raia wa Tanzania kwa mujibu wa Sheria za Uraia za Tanzania na :-

- (a) ameishi Zanzibar kwa muda wa miaka kumi na tano mfululizo; na
- (b) ana uwezo wa kutosha wa kuandika na kusoma Kiswahili; na
- (c) ni mtu mwenye tabia nzuri; na
- (d) kwamba ameingia Zanzibar kihalali na kuufuata Sheria na kanuni zote za Zanzibar; na
- (e) ni mwene umri kamili; na
- (f) anakusudia kuendelea kuishi Zanzibar, anaweza kuwa Mzanzibari.

- (a) ameyanganywa Uraia wake wa Tanzania; au
