AN ACT TO AMEND CERTAIN WRITTEN LAWS.

ENACTED by the House of Representatives of Zanzibar.

Short title. 1. This Act may be cited as the Written Laws (Miscellaneous Amendments) Act, 1987.

Certain laws amended. 2. The Laws set forth in the First Column of the Schedule to this Act are amended in the manner specified in the Second Column to the said Schedule.

Section 18 (1) (b) which repealed section 292 of the Criminal Procedure Decree Cap. 14 of the Laws of Zanzibar is hereby repealed and the said section 292 is hereby revived: Provided that section 292 of the Criminal Procedure Decree shall not apply to the control of

2. Criminal Procedure Decree Cap. 14 of the Laws of Zanzibar.	1. Part VII and VIII of the Criminal Procedure Decree which were repealed by Decree No. 3 of 1972 is hereby revived and shall have effect retrospectively from 1st January, 1987.
	2. Section 207, 208 and 209 of the Criminal Procedure Decree which were repealed by section 3 of Decree No. 2 of 1978 are hereby revived and shall have effect retrospectively from the 1st day of January, 1987.
3. The Magistrates' Court Act, No. 6 of 1985.	Section 21 is amended by deleting the words "hundred thousand shillings" wherever it occurs and replacing it by the words "two hundred thousand shillings".
3. The Road Traffic Decree, Cap. 135 of the Laws of Zanzibar.	If under any of the below mentioned sections or Parts, there is any subsidiary legislation made under the provision of that section or Part, then any of the penalty provided in the said subsidiary legislation shall cease to have effect forthwith and any offence provided therein shall have the same penalty under the corresponding provisions of the Parent Act. 
5. Penal Decree
Cap. 13 of the
Laws of Zanzibar.

Subsection (10) of section 248 as
amended by Decree No. 3 of 1969 is
hereby repealed and replaced by the
following:

"If cloves belonging to the Zanzibar
Revolutionary Government and its
parastatals are stolen, the offender
shall on conviction be liable to the
following penalties:

- (a) an imprisonment for a term
exceeding ten years.
- (b) While in the Educational Centre
shall grow and nurse hundred
clove trees.


