AN ACT TO PROVIDE FOR THE ESTABLISHMENT OF THE COMMISSION FOR LAND AND ENVIRONMENT, TO PROVIDE FOR ITS FUNCTIONS AND FOR OTHER MATTERS CONNECTED THEREWITH AND INCIDENTAL THERETO

ENACTED BY THE HOUSE OF REPRESENTATIVES OF ZANZIBAR.

PART I

PRELIMINARY

Short title
and
commencement.

Land and Environment Act, 1989 and shall come into
operation immediately upon being assented by the
President.

Interpretation. 2. In this Act, unless the context otherwise
 requires -

"Board" means the Board established under section 10 "CCM" means "Chama cha Mapinduzi";

"Commission" means the Commission established under section 3;

- "Director" means head of any department established under this Act;
- "Deputy Executive Secretary" means the Deputy
 Executive Secretary of the Commission
 appointed under section 5;
- "Executive Secretary" means the Executive Secretary of the Commission appointed under section 5;
- "Government" means the Revolutionary Government of Zanzibar;
- "Minister" means the Minister responsible for Land and Environment;
- "Natural land" refers to the natural land useful minus any man-made development thereon;
- "ownership" in relation to land, except for the Government which is the sole owner of all natural land, refers only to the development on the natural land or any connected with and incidental to it, including a legal right of occupancy on that land;
- "President" means the President of Zanzibar and Chairman of the Revolutionary Council.

PART II

THE COMMISSION FOR LAND AND ENVIRONMENT

Establishment of the Commission.

- 3.(1) There is hereby established a Commission to be know as the Commission for Land and Environment.
- (2) The Commission shall be a body corporate and shall -
 - (a) have perpetual succession and official seal;

- (b) in its corporate name, be capable of suing and be sued;
- (c) subject to this Act, be capable of holding, purchasing or acquiring in any other way any movable or immovable property and of disposing any of its property for the purpose of carrying out the functions conferred on the Commission by this Act.

Functions of the Commission.

- 4.(1) The Commission shall be the principal advisory and executive organ of the Government on all matters related to land use and conservation of environment and for that purpose, shall
 - (a) formulate policy on land administration and environment and recommend its implementation by the Government;
 - (b) co-ordinate the activities of all bodies concerned with land matters and environment and serve as a channel of communication between these bodies and the Government;
 - (c) encourage public institutions and private individuals involved in projects related to land and environment for the national interest;
 - (d) evaluate existing and proposed policies and the activities of the Government directed to safe guarding of land against its wrongful, wasteful or premature use or development and, on the basis of that, recommend to the Government policies and programmes which will achieve, more effective protection and enhancement of the land quality and encourage better use of land;
 - (e) recommend measures to ensure that Government policies including those for the development and conservation of land take adequate account of its effects on land and environment;

- (f) stimulate public and private participation in programmes and activities related to land use for the national beneficial use of the land;
- (g) foster co-operation between the Government, local Government authorities and other bodies of persons engaged in land and environment related programmes;
- (h) seek the advancement of scientific knowledge of changes in land use and encourage the development of technology to prevent or minimize adverse effects that endangers man's health or welfare;
- (i) specify standards, norms and criteria for the protection of beneficial uses and the maintenance of the quality of the land;
- (j) set suitable standards and criteria for protection of the environment in relation to atmosphere, ground water, sea water, vegetation and use of land in accordance with its carrying capacity;
- (k) establish and operate a system of documentation and dissemination of information relating to land and environment;
- (1) examine existing laws, and where appropriate formulate proposals for legislation in the area of land related matters and recommend their implementation by the Government;
- (m) establish and maintain liaison with other countries and international organizations with respect to issues and matters relating to land and the environment;

- (n) maintain co-ordination with the Land and Environment Advisory Committees in the Districts and Regions with respect to issues and matters related to land use so as to ensure that national and local interests in land use are taken into consideration;
- (o) prepare integrated regional economic land use plan, regional physical plans and ensure their implementation by the region;
- (p) undertake and promote general educational programmes in land and environment for the purpose of creating an enlightened public opinion regarding the land and the role of the public in its protection and improvement;
- (q) do all such acts as appear to it to be requisite, advantageous or convenient for or in connection with the carrying out of those functions or to be incidental to their proper performance and may carry on any activities in that behalf either alone or in association with any other person or institutions and perform such other functions as the Minister may assign to the Commission, or as are incidental or conducive to the exercise by the Commission of all or any of the preceding functions.
- (2) For the purposes of the better performance of its functions the Commission may establish and maintain a system of collaboration and consultation with any person or institution within or outside Tanzania having the same objectives and functions in relation to land matters and environment in general, provided that national interests are safeguarded.

(3) Any person who knowingly and without reasonable excuse hinders or obstructs the Commission or its authorized officer in carrying out any of its functions under this section shall be guilty of an offence and shall on conviction be liable to a fine not less than five thousand shillings (5,000/-) or to be sent to the education centre for a term not less than six months, or both such fine and confinement.

Executive Secretary.

- 5.(1) There shall be an Executive Secretary and Deputy Executive Secretary to the Commission who shall be appointed by the President on such terms and conditions as the President may determine.
- (2) No person shall be appointed Executive Secretary or Deputy Executive Secretary unless he has a sound educational and professional background in land and environmental affairs and have adequate experience in the management of the Government and public affairs.
- (3) The Executive Secretary and Deputy Executive Secretary of the Commission shall be the Chief Executive Officers of the Commission and shall, subject to the provisions of this Act and any directions which may be given to them by the Minister or Board, be responsible for the implementation of all decisions of the Board and for carrying out all the day to day activities of the Commission.
- (4) Executive Secretary and Deputy Executive Secretary of the Commission shall before assuming the duties of their office take oath of allegiance for the due execution of their office administered by the President as prescribed in the Schedule to this Act.

Duties of the Executive Secretary.

- 6.(1) Without prejudice to the generality of subsection (3) of section 5 of this Act it shall be the duty of the Executive Secretary, under the direction of the Minister and advice of the Board -
 - (a) to consider means and initiate steps in the safe-guarding of land and environment against its wrongful, wasteful or premature use or development;
 - (b) to carry out investigations into the problems of land and environment;
 - (c) to seek advice of persons having special knowledge, experience, or responsibility in regard to land and environment;
 - (d) to keep under review the progress made in the attainment of the objects and purposes of this Act and to publish reports and provide information for the purpose of enhancing public awareness of such progress and of the problems and remedies that exist in relation to land and environment;
 - (e) to promote, encourage, co-ordinate and carry out short-term and long-term planning and projects in land and environment together with or separate from other public bodies and other organs;
 - (f) generally, to administer and give effect to the provisions of this Act and to carry out other functions as may be prescribed by the Commission.
- (2) The functions of the Executive Secretary may be exercisable by the Deputy Executive Secretary in accordance with the directions issued from time to time by the Executive Secretary.

Departments of the Commission.

- 7.(1) There is hereby established the following departments under the Commission :-
 - (a) Department of Lands;
 - (b) Department of Surveys and Urban Planning;
 - (c) Department of Environment.
- (2) The President may establish any Department under the Commission.
- (3) The appointment of directors of the departments established or to be established under the Commission shall be made by the President.
- (4) No person shall be eligible for the post of Director in the Department of Lands or Department of Surveys and Urban Planning or Department of Environment unless he has educational and professional background in their respective field and have working experience of not less than five years.

Functions of the Departments.

- 8.(1) The Department of Lands established under this Act shall have the following functions:-
 - (a) to co-ordinate and supervise matters related to the administration of land in general and in particular to issue guidelines to institutions which use land or concerned in the utilization and administration of land in Zanzibar;
 - (b) to co-ordinate the activities of the Commission in the administration of land distribution for different purposes and finding administrative and legal strategies in settling land disputes arising from land distribution and land ownership.
 - (c) to lay down procedures for evaluation of land property and be the main co-ordinator to the Commission in the administration of the said procedures;

- (d) to keep records, documents and titles for the usufructory right in land in accordance with the Registered Land Act or as directed by the Commission;
- (e) to perform any other duties assigned to it by the Commission.
- (2) The department of Surveys and Urban planning established under this Act shall have the following functions:-
 - (a) to collect, keep and develop all information related to land survey and physical planning in Zanzibar;
 - (b) to prepare and revise the integrated regional economic land use and physical plans in the light of the existing or future development sectional policy;
 - (c) to advise on methods and ensure the implementation of the integrated regional economic land use plan;
 - (d) to advise and co-ordinate the implementation, initiation in the revision of laws and regulations related to survey and urban planning;
 - (e) to co-ordinate all activities related to land survey and drawing of maps and charts for the land and sea respectively;
 - (f) to perform any other duties assigned to it by the Commission.
- (3) The Department of Environment established under this Act shall have the following functions:-
 - (a) to conduct research in the environmental conditions and on how it is affecting different activities such as agriculture, animal husbandry, industries, tourism and construction;

- (b) to formulate a policy on conservation of environment;
- (c) to advise on methods to ensure the implementation of the policy on conservation of environment;
- (d) to perform any other duties assigned to it by the Commission.

The staff of the Commission.

9. In consultation with appropriate authority, the Commission may appoint on such terms and conditions as it may determine, such number of staff and experts to serve as officers of the Commission as it may consider appropriate or necessary for the performance of the functions of the Commission.

- 10.(1) There is hereby established a Board to be known as the National Advisory Board for Land and Environment.
- (2) The Board shall supervise and direct the Commission and advise the Minister on matters related to land and environment.

Composition of the Board.

- 11. The Board shall consist of the following
 members :-
 - (a) Minister responsible for Regional
 Administration Chairman;
 - (b) Attorney-General or his representative - Member;
 - (c) Members of the National
 Executive Committee of
 CCM from Zanzibar who shall
 not exceed three appointed
 by the Minister Members:
 - (d) Members of the Parliament of Tanzania from Zanzibar and or members of the House of Representatives whose number shall not exceed 3 appointed by the Minister - Members;

- (e) Persons who are experts and conversant in the field of land shall not exceed five appointed by the Minister - Members;
- (g) Executive Secretary of the
 Commission for Wakf and
 Public Trustee Member:
- (h) Executive Secretary of the Commission for Land and Environment - Secretary.

Regional and District Advisory Committees.

- 12.(1) There is hereby established in every region and every district in Zanzibar Committee to be known as the Regional Land and Environment Advisory Committee and District Land and Environment Advisory Committee respectively.
- (2) In discharging its duties, the Commission shall work through the Land Advisory Committees established in the districts and regions for the overall supervision of all activities pertaining to land and environment in the respective districts and regions. The Commission shall have power to issue orders, directions, notices or other documents to the District and Regional Land and Environment Advisory Committees and all such orders directions and notices shall be binding.
- (3) The Minister may make Rules prescribing the procedure for the implementation by the committees of the orders, directions and other matters, issued by the Commission.

Composition of the Regional and District Land and Environment Advisory Committee.

- 13.(1) The Regional Land and Environment Advisory Committee established under the provisions of this Act shall consist of the following:-
 - (a) Regional Commissioner Chairman;
 - (b) Regional Administrative Officer Secretary;
 - (c) Regional Party Secretary Member
 - (d) One member of the House of
 Representatives and one member
 of the Parliament of Tanzania
 in the Region appointed
 by the Minister Member;
 - (e) Member of the National

 Executive Committee of CCM

 appointed by the Minister Member;
 - (f) Regional Agricultural Officer Member;
 - (g) Regional Forestry Officer Member;
 - (h) Regional Land Officer Member;
 - (i) Regional Survey and Urban
 Planning Officer Member:
 - (j) Regional Environment Officer Member;
 - (k) Director of Municipality/ Secretary of the Town Council - Member.
- (2) The District Land and Environment Advisory Committee established under the provisions of this Act shall consist of the following:-
 - (a) District Commissioner Chairman;
 - (b) District Administrative Officer Secretary;
 - (c) Member of the National
 Executive Committee of CCM
 appointed by the Minister Member;
 - (d) District Party Secretary Member;

- (e) A member of the House of
 Representatives and a member
 of the Parliament in the
 District appointed by
 the Minister
 - Member;
- (f) A councillor of the Local
 Government appointed
 by the Minister Member;
- (g) District Agricultural Officer Member;
- (h) District Land Officer Member:
- (i) District Forestry Officer Member;
- (j) District Survey and UrbanPlanning Officer Member;
- (k) District Environment Officer Member;
- (1) Secretary of the Town Council Member.

Functions of the Regional and District Land Advisory Committees.

- 14.(1) The Regional Land and Environment Advisory Committee established under provisions of this Act shall perform the following functions:-
 - (a) to advise on the preparation, implementation and review of the integrated regional economic land use plan and consservation of environment in their regions;
 - (b) to supervise the implementation of the integrated regional economic land use plan in their respective regions and to ensure standards set and procedure for the land utilization in general is followed;
 - (c) to co-ordinate all institutions in their districts related to land utilization and act as link and source of information between the District and the Regional Government;

- (d) to advise on methods which shall ensure the integrated regional economic land use plan take into consideration adverse effect of various land uses;
- (e) to review the implementation of laws related to land and environment and advise and propose amendment on the same where necessary;
- (f) to establish and maintain good relations between the Commission and the Regional and District Committees;
- (g) to perform any other direction given by the Commission.
- (2) The District Land and Environment Advisory Committee established under the provisions of this Act shall perform the following functions:-
 - (a) to supervise the implementation of the integrated regional economic land use plan in their respective Districts and ensure standards set and procedures for the land utilization in general are followed;
 - (b) to co-ordinate all institutions in their District related to land utilization and act as link and source of information between the District and the local Government in their Districts;
 - (c) to advise on methods which shall ensure the integrated regional economic land use plan take into consideration adverse effect of various land uses;
 - (d) to review the implementation of laws related to land and environment and advise and propose amendment on the same where necessary.

Tenure of office.

15.(1) All appointed members under sections 11 and 13 shall remain in office for a term of three years from the date of their appointment and may be eligible for re-appointment.

- (2) Any appointment made under sections 11 and 13 may at any time, be revoked by its appointing authority when it deems fit or after receiving a resignation from the member.
- (3) All appointments made under sections 11 and 13 and all revocations made under subsection (2) of this section shall be published in the Official Gazette.

Sub-Committees. 16. Subject to the approval of the Minister, the Commission may, from time to time establish such sub-committees amongst the Board members or invites persons who are not Board members and who are experts in different field of learning as it may consider necessary for the purpose of facilitating the carrying out of the objectives and function of the Commission.

Meeting procedure and quorum.

17. The Board, Committees and sub-committees established under this Act shall regulate its own meeting procedures:

Provided that the quorum at any meeting of the Board, Committee and sub-committees established under this Act shall be half of all members.

Commission call for information.

- 18.(1) The Commission may require in writing any person or body of persons engaged in research or engaged in an activity affecting or relating to land and environment in Zanzibar, to furnish to it such information related to that research or activity as the Commission may specify.
- (2) Every person or body of persons which is required to furnish information under subsection (1) shall comply with the requirement and any person or body of persons which refuses or fails to comply with that requirement shall be guilty of an offence and shall be liable on conviction to a fine not less than ten thousand shillings or to be sent to the education centre for a term not less than six months or to both such fine and imprisonment.

Offences and penalties.

- 19.(1) Any person destroys or pollutes environment or land or uses lands or environment in such a manner contrary to directions and procedures established by the Commission commits an offence and shall on conviction be liable to be sent to the Education Centre for a period of not less than two years or to a fine of not less than fifty thousand shillings or to both such fine and confinement.
- (2) In addition to the penalty provided under the provisions of subsection (1) of this section the Court may issue any order which it deems fit.

Regulations.

- 20.(1) The Minister may make Regulations for the better carrying out the provisions of this Act.
- (2) Without prejudice to the generality of the foregoing provision the Minister may -
 - (a) provide for the charges for any services rendered by the Commission or its Committees;
 - (b) give to the Commission directions of a general or specific character regarding the performance by the Commission of any of its functions.
