#### AN ACT TO ENACT THE DIASPORA AFFAIRS ACT WHICH PROVIDES FOR THE MATTERS CONNECTED THEREWITH AND INCIDENTAL THERETO

**ENACTED** by the House of Representatives of Zanzibar.

#### PART ONE PRELIMINARY PROVISIONS

Short Title and Commence-ment.

1. This Act may be cited as the Diaspora Affairs Act, 2020 and shall come into operation on such a date as the Minister may appoint by notice in the Gazette.

Application

2. This Act shall apply on the matters concerned to all registered and non-registered Diaspora and for the matters related to Zanzibar.

Interpretation.

- 3. In this Act, unless the context otherwise requires:
  - "Affiliated to Zanzibar" means a person of origin, relation, connection, adoption or association with Zanzibar society by mutual consent under conditions agreed;

"Designated Person" means a person appointed by the President under section 4 of this Act;



- "Diaspora Associations" means organization formed by Diaspora either in or outside of Zanzibar;
- "Diaspora Forum" means a body formed under section 14 of this Act that performs a specific activity and task in field of cooperation and promotion of the Diaspora relationship;
- "Diaspora" means a person as prescribed under section 6 of this Act;
- "Indefinite Period" means a period of not less than seven years of Diaspora living abroad;
- "Minister" means the Minister responsible for matters relating to the Diaspora Affairs;
- "President" means the President of Zanzibar and Chairman of the Revolutionary Council;
- "Registered Diaspora" means a person registered under section 8 of this Act.

#### PART TWO ADMINISTRATIVE PROVISIONS

Appointment of a Person Responsible for Diaspora Affairs.

- **4.-**(1) The President shall, by the executive order, establish an Office and appoint a person who shall be responsible for Diaspora affairs in Zanzibar.
- (2) Designation or title of such person shall be according to the Order of the President under subsection (1) of this section.

Functions of the Office of Diaspora Affairs.

- 5. The functions of the Office established under section 4 of this Act shall be to:
  - (a) facilitate privileges provided under this Act;
  - (b) establish, register and maintain the records of Diaspora;
  - (c) facilitate in financial, social security, land and investment matters, trade and tourism matters;
  - (d) facilitate issue of identification cards according to the Act No. 3 of 2018;
  - (e) facilitate receiving of Diaspora philanthropic resources and services;



- (f) collaborate with the Diaspora associations and other international organisations;
- (g) ensure that Diaspora issues are incorporated in the sectorial policies and programs;
- (h) promote establishment of various Diaspora associations;
- (i) monitor and evaluate implementation of the Diaspora Policy;
- (j) promote conditions that will enable Diaspora to learn and preserve Kiswahili and Culture;
- (k) provide access to current information to Diaspora through Government media and official websites;
- (l) strengthen social and economic links with Diaspora in the areas of science and development of new technology;
- (m) develop standards of performance to be observed and achieved by the Diaspora;
- (n) organise and provide secretariat services for the Diaspora Forum and Conference:
- (o) provide public awareness on the Diaspora issues; and
- (p) do any other matters related herewith.

# PART THREE STATUS AND PRIVILEGE OF DIASPORA IN ZANZIBAR

Diaspora.

- **6.-**(1) There shall be a person to be known as Diaspora who migrates and resides outside the United Republic of Tanzania for indefinite period while still maintains his affinity to Zanzibar.
  - (2) A person shall be identified to be a Diaspora if he has the following criteria:
    - (a) is affiliated to Zanzibar;
    - (b) has allegiance to Zanzibar;
    - (c) he recognises and respects the 1964 Zanzibar Revolution;



- (d) he adheres to the Constitution and laws of Zanzibar and the United of Republic of Tanzania; and
- (e) he holds the United Republic of Tanzania passport or any other passport.

### Register of Diaspora.

- 7.-(1) Subject to the provisions of section 5 of this Act, there shall be a Register to maintain records of registered Diaspora.
  - (2) The Register shall keep the records of Diaspora based on:
    - (a) name of Diaspora:
    - (b) nationality;
    - (c) country of residence;
    - (d) gender;
    - (e) skills and experience; and
    - (f) any other related information.
- (3) Individual records and information maintained in the Register shall be confidential.

### Registration of Diaspora.

- **8.-**(1) Diaspora may apply for registration to the office responsible for the Diaspora affairs.
- (2) Designated Person shall scrutinize the application made by the Diaspora under this section to assess the criteria for registration.

# Powers of Designated Person.

- **9.-**(1) Designated Person shall have power to deny a registration application of the Diaspora if not satisfied with the criteria for registration provided under this Act.
- (2) Designated Person may deregister Diaspora if not comply to the provisions of this Act.

#### Notification.

- **10.-**(1) The Designated Person shall notify in writing Diaspora on the refusal of application for registration or deregistration.
- (2) If a Diaspera is not satisfied with the decision made by the Designated Person, may appeal to the Minister within 30 days from the date of notification.



Privileges of the Registered Diaspora.

- 11.-(1) Subject to the laws of the United Republic of Tanzania and the laws of Zanzibar, the registered Diaspora may have the following privileges:
  - (a) exemption from work permit;
  - (b) grant of multiple-entry and multi-purpose long term visa to visit Zanzibar; and
  - (c) permission for long stay in Zanzibar.
- (2) Subject to subsection (1) of this section, a registered Diaspora shall request the privilege to the office responsible for the Diaspora affairs.

Responsibility of Diaspora.

- 12. The Registered Diaspora shall have the responsibility:
  - (a) not to misuse the privileges provided under this Act;
  - (b) to promote, uphold and preserve interest of Zanzibar in relation to tourism, investment, culture, education, health, sports, scientific and philanthropically assistance; and
  - (c) to maintain and strengthen the ties between Zanzibar and his country of residence.

Prohibition.

- 13.-(1) The Diaspora shall not:
  - (a) participate in political issues including right to join political parties, vote or be voted for; and
  - (b) have any other right that is reserved exclusively to Zanzibari resident as the Minister may publish from time to time.
- (2) Without prejudice to the provisions of subsection (1) of this section, a registered Diaspora who is Tanzanian National shall be entitled to have all rights according to the laws of the United Republic of Tanzania and Zanzibar.



#### PART FOUR MISCELLANEOUS PROVISIONS

Diaspora Forum.

- **14.-**(1) There shall be a Diaspora Forum whose members shall be appointed by the Minister.
- (2) The composition of the Diaspora Forum shall be as prescribed in the Regulation.
  - (3) The Minister shall be a Chairman of the Diaspora Forum.

Function of the Diaspora Forum.

- **15.-**(1) Subject to the provisions of this Act, the functions of the Diaspora Forum shall be to:
  - (a) provide advice on the Diaspora Policy matters;
  - (b) ensure successful preparation of the Diaspora Conferences;
  - (c) advise on facilitation of the Diaspora Forum;
  - (d) organize and motivate economic, cultural, educational, health, scientific and sport cooperation with the Diaspora; and
  - (e) advise conditions favourable for investment programs and projects established by Diaspora.
- (2) Subject to the provisions of this section, the Diaspora Forum may regulate its own procedures.

Diaspora Conference.

- **16.-**(1) There shall be a Diaspora Conference to be conducted as it may deem necessary.
- (2) The Diaspora Conference shall consist of registered and non registered Diaspora and other stakeholders to discuss Diaspora matters and other related issues.

Offences and Penalties.

17.-(1) It shall be an offence for any person to misuse and contravene the privileges provided under this Act.



- (2) A person who contravenes the provisions under subsection (1) of this section, commits an offence and upon conviction, shall be liable to be deprived the privileges provided and a fine of not exceeding One Million Tanzanian Shillings or to imprisonment for a term not exceeding one year or both.
- (3) A person who solicits, incites, abets or induces a Diaspora to commit an offence, commits an offence and upon conviction, shall be liable to a fine of not exceeding One Million Tanzanian Shillings or to imprisonment for a term not less than one year or both.

Minister to Make Regulations.

- **18.-**(1) The Minister may generally make Regulations for the better performance of the provisions of this Act.
- (2) Without prejudice to the generality of the powers under subsection (1) of this section, the Minister may specifically make regulations on the following matters:
  - (a) providing composition of the members of the Diaspora Forum;
  - (b) providing for procedures of appeal to the Minister; and
  - (c) providing for criteria and procedures for registration of the Diaspora including prescribed fees.
