## AN ACT TO AMEND VARIOUS LAWS AND MAKE BETTER PROVISIONS THEREOF

**ENACTED** by the House of Representatives of Zanzibar.

### PART ONE PRELIMINARY PROVISIONS

Short title and commencement. 1. This Act may be cited as the Written Laws (Miscellaneous Amendment) Act, 2022 and shall come into operation after being assented to by the President and published in the Gazette.

Amendment of certain Laws.

2. The Written Laws specified in various parts of this Act are amended in the manner specified in their respective parts.

### PART TWO AMENDMENT OF THE WORKER'S COMPENSATION ACT, NO. 15 OF 1986

Construction.

3. This Part shall be read as one with the Worker's Compensation Act, No. 15 of 1986, in this Part referred to as "the Principal Act".

Amendment of section 2.

- 4. Section 2 of the Principal Act is amended by:
  - (a) repealing subsection (2) and replacing it by a new subsection (2) as follows:



- "(2) This Act shall not apply to workers employed in the Government of United Republic of Tanzania Institutions at Zanzibar and workers in public or private sector in Zanzibar who are members of the Zanzibar Social Security Fund;"
- (b) adding new subsection (3) immediately after subsection (2) as follows:
  - "(3) All workers in public and private sectors who are members of the Zanzibar Social Security Fund shall be paid an employment injury benefit in accordance with the provisions under the Zanzibar Social Security Fund Act and its Regulations.
- (c) renumbering subsection (3) to be subsection (4).

# PART THREE AMENDMENT OF THE ZANZIBAR TAX APPEALS ACT, NO. 1 OF 2006

Construction.

5. This Part shall be read as one with the Zanzibar Tax Appeals Act, No. 1 of 2006, in this Part referred to as "the Principal Act".

Amendment of section 25.

- 6. Section 25 of the Principal Act is amended by adding new subsections (6) and (7) immediately after subsection (5) as follows:
  - "(6) A party to an appeal may, at any stage of the proceedings before the judgment is delivered by the Board or Tribunal as the case may be, apply for appeal to be settled amicably.
  - (7) For the purpose of subsection (6) of this section, the Board or Tribunal shall:
  - (a) require the parties to report the outcome of the amicable settlement within a specified time and the Board or Tribunal shall issue a final order with respect to such amicable settlement;
  - (b) issue a final order upon submission of a settlement agreement duly signed by both parties; and
  - (c) not entertain an issue which has been settled amicable by parties under the provisions of this section".



# PART FOUR AMENDMENT OF THE ZANZIBAR SOCIAL SECURITY FUND ACT, NO. 2 OF 2005

Construction.

7. This Part shall be read as one with the Zanzibar Social Security Fund Act, No. 2 of 2005 in this Part referred to as "the Principal Act".

Amendment of the First Schedule.

- 8. The First Schedule of the Principal Act is amended by:
  - (a) adding a new paragraph (d) immediately after paragraph (c) of the item 2 as follows:
    - "(d) employment injury benefit one percent".
  - (b) deleting the word "thirteen" and substituting it by the word "fourteen" in paragraph (b) of item 3.

### PART FIVE AMENDMENT OF THE ZANZIBAR UTILITIES REGULATORY AUTHORITY ACT, NO. 7 OF 2013

Construction.

9. This Part shall be read as one with the Zanzibar Utilities Regulatory Authority Act, No. 7 of 2013 in this Part referred to as "the Principal Act".

Repeal of sections 33, 34 and 35.

10. Sections 33, 34 and 35 of the Principal Act are hereby repealed.

## PART SIX AMENDMENT OF THE COMPANIES ACT, NO.15 OF 2013

Construction.

11. This Part shall be read as one with the Companies Act, No.15 of 2013 in this Part referred to as "the Principal Act".

Amendment of section 238.

12. Section 238 of the Principal Act is amended by repealing subsection (3).
